- 1.0 Owen welcomed everyone to the meeting and noted the meeting on the 27 April was cancelled due to low numbers planning to attend. Owen particularly welcomed Claire Thompson 2nd year Pre- registration QUB student to the group and noted her recent work regarding MAKATON and her invitation to the recent Kings Coronation 7th May 2023.
- 2.0 The note of last meeting 9th March 2023 was agreed as an accurate reflection with the exception of correspondence from Damian McAleer from CEC who had raised a discussion point on where 'the region' is at following the Roll-out of RESPOND (Trauma Champion Training) that many of our practitioners completed which was omitted form the note of the meeting .This has been added as an agenda item to this meeting under AOB
- 3.0 Update on Actions
 - **AP 13** F Cannon highlighted papers circulated following the last meeting included:
 - population health needs of people with learning disabilities *draft paper*
 - RNLD workforce in the HSC draft paper
 - Learning and Development Framework-Strategic RNLD Workforce Engagement Event *draft paper* circulated

no feedback or comments was returned from ERG members (closed)

AP 9 L Marsh has nominated a 2nd year student - Claire Thompson (who attended today) closed

- 4.0 Update from RNLD Strategic Development Project Group
 - Population Health Needs
 - Regional Workforce Model
 - Learning and Development Framework
 - Professional Leadership

Owen updated the group on information regarding pre and post registration commissioned programmes received from DOH.

Owen highlighted that number of student places on pre-reg are decreased having been increased during 2018/19 – 2022/23 with decrease 2023/2024 Following discussion, it was agreed to ask the members to gather information on generic programmes completed by RNLDs for the past 3 years

Action Point 14 Frances to link with RNLD Consultant nurses prepare a proforma to gather this information

Based on the work progressed so far Owen provided a presentation on the proposed model for RNLD Nursing. Owen highlighted it is not for sharing at this time as it is still not finally agreed. Some discussion points highlighted included

- ✓ OB highlighted that the model is based on person centred outcomes
- ✓ In principle the model is welcomed (by members) and feedback was positive

- ✓ ERG members highlighted the use of terminology and sought clarification particularly in relation to "involvement" and what this means
- √ There was (is a risk) that parallel services are developed
- ✓ Should include physical & mental health explicitly
- ✓ Helpful to include Health Improvement rather than "physical checks" need to evidence follow through of physical checks follow up
- ✓ Reduce use of acronyms
- ✓ Acute Liaison Nurses (ALN) needs to be firmly based in the general hospital across all settings – need to agree who the ALN is managed by
- ✓ Need for regionally agreed JDs and roles
- ✓ Highlighted that as part of Encompass there may be an alert to say that someone has a learning disability – it was highlighted that this approach has not been used very successfully in the past
- ✓ Highlighted that there are growing number of RNLDs working as HV & they are moving away from learning disability services (and this is very disappointing) under AOB Maurice asked that as part of the workforce paper to have a think about the point made re RNLDs employed outside of learning disability services, actively losing their connection with learning disabilities. Recognised this is an important but very unfortunate situation Owen acknowledged this needed to be reflected in the paper
- ✓ Request to highlighted that in the workforce paper and examples from practice settings – recognised this is an issue
- ✓ Discussion regarding the pro and cons and establishment of parallel services in terms of professional support particularly
- √ (from chat box) Suggest amalgamating CNLD with the Acute LN and Health Facilitator - all linked to for expert engagement and reference ...thus promoting reasonable adjustments and to enable equal access to services
- ✓ Use of Evidence based Outcomes Based Tools
- ✓ WHSCT looking at pathways for people with mental health problems so this
 model is very timely (recognised that other HSCT doing similar)
- Mental Health nurses need support to care for people with learning disabilities may be a need to look at CPD particularly for people with complex Learning Disabilities
- √ (from chat box) Mental health Nurses reporting a lack an understanding of how to communicate with a person with a learning disability. The lack of understanding regarding reasonable adjustments - we have an expectation that other services make reasonable adjustments - language used, support of the person to deescalate anxiety etc but Mental Health have been very resistant. They build barriers rather than reduce them but they have the skills to assist with some very challenging and complex Mental III Health within the general population
- ✓ Use of real-life examples might be useful
- ✓ Care delivery is often dictated by service delivery model
- ✓ The model needs to align to strategic vision real desire to have sight of the DOH RNLD workforce review
- ✓ Any model needs to take into consideration complexity of learning disabilities of the individual and the support required and what this will look like

Owen highlighted that Cathy McCusker is the lead on the development of a career pathway in NIPEC and has suggested inviting her to the next ERG meeting 29th June which is face to face to talk through the steps in developing a career pathway based on the model including the following

- defining and agreeing the roles
- agreeing the JDs and banding
- agreeing the educational requirements
- sharing a Career pathway which has been already completed

When we come together on the 29th June we should be in a position to think about career pathway for RNLDs

5.0 RNLD Community of Practice

Clionagh McElhinney updated the group on the Communities of Practice - Learning Disabilities Nursing Launch Event *Previously known as the RNLD Professional Development Forum (PDF)* on Friday 28TH April 14:00 – 16:00. The Communities of Practice aims to provide a platform for all Registered Nurses Learning Disabilities (RNLDs) and other nurses who have an interest in supporting people with learning disabilities - across all settings to include HSC Trusts, the education sector and the independent/voluntary sector

86 people attended the virtual event which was very informative and highly interactive. Key leaders leading the work of the RNLS Strategic workforce development project provided presentations on the following

- ✓ Recommendations of the DOH Workforce Review of the role of RNLDs
- ✓ An overview of the RNLD Strategic Workforce Development Project
- ✓ Update on workstreams aligned to the RNLD Strategic Workforce Development Project
- ✓ An update on the New Learning Disabilities Service Framework Model

6.0 Next steps/AOB

Little seems to be known as to what is happing in this space.
