4.0 Synopsis of work to date

LN advised that since the last Steering Group meeting in March 2023, a further workshop has been held on 23 May 2023. Although the workshop focused on adult nursing, PMcN and BMcS also attended to assist with their Children`s roles.

LN praised the excellent work of the writing groups to date.

Since the last meeting, the following work has been progressed:

- Draft Role Descriptors developed;
- The ACCEND Competencies have been reviewed;
- Draft Educational Requirements have been developed.

LN noted 2 key learning points; It was useful to have members sitting on more than one Writing Group's as it helped inform role clarification, and how invaluable the input of HEI's and CEC colleagues has been.

The workshop was the first opportunity for the RDWGs to collectively review the Role Descriptors.

LN advised that this gave attendees an opportunity to review the Cancer Support Worker Role including its clinical function.

LN also shared the distinction was being identified within the Registered Nurse roles; which has led the need to further describe the Senior Cancer Nurse role. LM and LN have drafted a Role Descriptor and Competencies with the Registered Nurse RDWG.

LN acknowledged that the review of the ACCEND Capabilities is a lengthy process; the creators of the document have been contacted, and will meet with LN and LM to discuss the amendments identified during this process of the considerations, from a Northern Ireland approach.

LN advised that due to the volume of work required in order to update the Cancer roles, the project timelines have drifted. A further workshop is planned to complete

the remaining tasks, for 4 July 2023.

The RDWGs Co-leads provided an update on their progress to date:

Nicola Shannon - Registered Nurse Group:

 NS advised that the workshop on 23rd May was a good opportunity to raise any queries, and share the voice of their RDWG.

Matthew Kelly – **ONP/HNP Group**:

 MK noted that the group is on track, and that the workshop was very useful for linking in with colleagues.

Louise Gribben - ANP Writing Group:

 LG advised that the ANP group is also on track, and that the members are well placed to complete this work. LG advised that ACCEND provided a framework for a newly registered ANP, with opportunity to develop within the role.

Sheena Stothers – **Consultant Nurse Group**:

- SS noted that the CN group were engaged and provided useful ideas and feedback.

Bernie McShane - Children's Group:

 BMcS noted there was great engagement at the workshop, and that the Children's group looked at all of the roles across 2 documents. A further meeting is planned with LM and LN for the 9 June 2023.

5.0 Workplan & Timescales - progress update

GMcK gave an overview of the Workplan & Timescales:

- Some extra time has been required for the development of the Educational Requirements and completing the remaining Competency domains. An additional workshop is planned for the 4 July 2023, to finalise and agree these.
- The project GANTT chart and timescales to be updated.
- Role Descriptors, Education Requirements, and Competencies are to be completed and shared with the Steering Group, planned for 14 September 2023.
